If, for any reason the monthly dues charge and any other Center charges are not accepted by the credit card company, I understand that a \$10 service charge will be added to my bill and I am responsible for payment. This service charge may change from time to time with notice.  
**TERMS:** This authority is to remain in effect for a minimum of twelve months from the date upon which monthly dues billing commences.

### Terms of Membership

I understand that my membership is for an initial twelve month period and that it shall continue on a monthly basis afterward unless I decide to cancel. If I decide to cancel my membership after the initial twelve month period, I will provide the Center with a written notice of my intention to cancel by the twentieth (20th) day of the month of the final billing. Upon acceptance of this Agreement by the Center, I will receive all membership rights and privileges. I agree to abide by all Policies, Rules, and Procedures of the Center, which are subject to change without notice. I understand that, historically, the Center has raised its dues and other rates once per year, and that the Center reserves the right to raise dues with notice and other rates without notice at anytime, including the initial twelve months of this agreement. I understand that my membership may be terminated by the Center if I am in violation of the Court Policies, Rules, and Procedures, conduct myself in a manner which management deems inappropriate or disruptive to other Center members or staff, or make false representation of information contained in this Agreement, or for any reason without notice at any time. Notwithstanding the previous sentence, I will be responsible for the payment of all monthly dues and other Center charges under this Agreement.

### Acceptance of Membership Agreement

No one has the right or authority to make any changes to the terms of this Agreement for the Center, except an officer of the Center (who may only do so in writing).

This Agreement is the entire agreement pertaining to membership and supersedes any other promises, representations, or understandings of any kind, whether written or oral. This Agreement is governed by the laws of PA. In the event any provision of this Agreement is ever deemed unenforceable, all other provisions shall remain in full force and effect. The Center will not lose its rights under this Agreement if it delays in enforcing them or fails to enforce such rights and the other persons become members under this Agreement agree to be jointly and severally liable for our obligations under this Agreement. I understand that this Agreement includes the provisions contained in the pages, including any Addendum, that are attached and which are made a part of this Agreement.

I acknowledge that before I signed this Agreement, including the Waiver and Release, I had reasonable opportunity to examine it and I understand it. I further acknowledge that I have received a copy of Court Policies (see below).

I understand that my membership is continuous and requires no annual renewal and that my membership is in effect for a minimum of twelve months. If I decide to cancel my membership (after the initial twelve months), I will provide the Center with written notice by the twentieth (20th) day of the month of the final billing.

### **Court Policies, Rules, and Procedures**

1. Please wear appropriate attire on courts. Shirts must be worn, non-marking tennis shoes only, no cut-offs or jeans.
2. Drinks must be in non-spill, leak-proof bottles or cups.
3. No profanities, yelling, screaming, or throwing racquets.
4. No hitting nets, curtains, or walls with racquets unless by accident.
5. Inappropriate behavior will not be tolerated and is grounds for being banned from future use of the Center.
6. Show respect to all players at all times. Cell phones must be placed in silent mode.
7. Please keep courts clean by picking up all balls and throwing away any trash.
8. All booking privileges are currently to be made through the Center staff. Once available, online court reservation software will be in place and can be utilized.
9. Do not retrieve a ball from another court while their point is still in play.
10. If you are near tennis courts but not playing, please keep noise to an appropriate level to respect the players.
11. Court time and lessons have a 3-hour cancellation policy. "No Shows" will be charged for that reservation. Full charges apply.
12. Use of courts prior to or beyond assigned times is subject to charge.
13. Teaching and/or Instruction at the Center is allowed by Center staff pros only.
14. The Center reserves the right to cancel or re-schedule court time for any reason deemed appropriate per sole discretion of management.
15. The Center is not responsible for lost or stolen items.
16. Smoking is prohibited.
17. Pets are prohibited.
18. Ball machines are prohibited. Rental of the Center ball machine is available.

All Play is at your own risk and player represents he/she is in good physical health.
